Section on Child Maltreatment

- Mission: To support and promote scientific inquiry, training, professional practice, and advocacy in the area of child maltreatment
- Only permanent organization within APA specifically developed to address issues related to child abuse and neglect

A look back in time: 1996

- Research and Data:
 - 3rd National Incidence Study showing CAN increase
 - 1st Edition of the APSAC Handbook on Child Maltreatment
 - Barnett et al.'s Maltreatment Classification System (1993)
- Policy:
 - Family Preservation and Family Support Services (1993)
 - Adoption and Safe Families Act in the works (1997)
 - CAPTA reauthorization
- Practice:
 - Trauma Focused Cognitive Behavior Therapy (TFCBT)
