

CONGRESSIONAL INVOLVEMENT

- Congressional Briefing, 2002: In conjunction with APA and Consortium on Children, Families and the Law, sponsored briefing on child abuse prevention entitled, "Protecting Our Nations Children: What We Know About Child Abuse Prevention." Members present included Jeff Haugaard, Sharon Portwood, Linda Smith, and Dan Dodgen.
- Amicus brief: In collaboration with the National Association of Counsel for Children, the American Professional Society on the Abuse of Children, and the California Professional Society on the Abuse of Children, Section members developed and submitted an amicus brief to the US Supreme Court in Stogner v. California, a case involving the application of statutes of limitations in child sexual abuse cases.

INCREASING MEMBER AWARENESS REGARDING PUBLIC POLICY

Section Website:

TASK FORCES ON PUBLIC POLICY ISSUES

- Task Force on Corporal punishment updated the 1975 APA resolution opposing "the use of corporal punishment in schools, juvenile facilities, child care, nurseries, and all other institutions, public or private, where children are cared for or educated."
- Division 37 and Section on Child Maltreatment joint Task Force for Child and Advocacy Training (2006) – released "A Psychologists' Guide for Advocacy: Legislative Support for Children, Youth, and Families", designed to build advocacy capacity and advance application of psychological knowledge to public policy affecting children, youth, and families.
- Interdivisional Task Force on Child Abuse Prevention (2006), Sponsored by divisions 37 and 41, addressed state of science on child maltreatment prevention and worked to identify & disseminate promising programs.

TASK FORCES ON PUBLIC POLICY ISSUES (CONT.)

- Former Section President Anthony Mannarino, PhD served on the APA Presidential Task Force on Posttraumatic Stress Disorder and Trauma in Children and Adolescents in 2008 – developed a summary paper about childhood PTSD and trauma, a briefing sheet, and a bookmark on "what every mental health professional should know" about child PTSD and trauma.
- Preston A. Britner, Member-at-Large in 2008, participated in APA Working Group on Child Maltreatment Prevention through Community Health Centers (CHCs). Objective was to (a) explore integration of behavioral health professionals, particularly psychologists, into CHCs to prevent child maltreatment and (b) recommend public health strategies to promote safe, stable, nurturing relationships for children and positive parenting practice within this context.

PROFESSIONAL INVOLVEMENT REGARDING PUBLIC POLICY

- Cosponsored the 2004 Annual Colloquium of the American Professional Society on the Abuse of Children (APSAC)
- Members have served on steering committee for the American Bar Association (ABA)/APA Conference on Children and the Law

CURRENT RESEARCH IN PUBLIC POLICY

- **David Finkelhor, PhD,** of the Crimes against Research Center, at the University of New Hampshire, along with Heather Turner, PhD, and Sherry Hamby, PhD, are working on the National Survey of Children Exposed to Violence (NatSCEV). This is an effort, funded by the US Department of Justice, to improve the assessment of children for a broad range of threats to their safety. The project has been a cornerstone of Attorney General Eric Holder's Defending Childhood initiative. Toolkits are being prepared to help communities and agencies use the resources of the project to assess groups of children and to monitor trends.
- Lisa M. Jones, PhD, at the University of New Hampshire, Crimes Against Children Research Center is working on project funded by NIJ to evaluate approaches to youth Internet safety education. The project will result in recommendations and tools for those developing and funding Internet safety programs as well as school and law enforcement educators.
